Sole operator advertising policy

- 1. Section 93(2) of the *Prostitution Act 1999* states that a person must not publish an advertisement that is not in the approved form. 'Approved form' includes the size, colour and content (photos, drawings, wording) of the advertisement. Depending on where the advertisement is to be placed, the PLA may seek further information from the applicant.
- 2. It cannot be assumed that the approval of content in one form of advertising is transferable to another form of advertising. Each new form of advertising must be submitted to the PLA for specific approval.

General print publications, including newspapers, magazines and tourist publications

- 3. An advertisement advertising the services of a sole operator for publication in print media may include the following information:
 - The name of the person or business, provided that the name does not describe the services offered
 - Approved words and phrases
 - The address from which the business operates
 - The telephone or contact details of the business.

Attachment A contains a list of words and phrases that have been approved by the PLA. Any other information intended to be included in the advertisement must have the prior approval of the Prostitution Licensing Authority.

- 4. An advertisement may also include approved line drawings or pencil renderings as well as a photograph of only the head and shoulders of the person offering the prostitution services.
- 5. The advertisement must not be of a size greater than 5cm in height and 7.2 cm in width or greater in area than the equivalent area constituted by those dimensions. However, should a publication not offer advertising of that size, an application must be made to the PLA for consideration of the proposed advertising. Such application must identify the publication and be accompanied by a copy of the publication.
- 6. The advertisement may be in colour or black and white.

Print publications classified by the Office of Film and Literature Classification (adult publications)

7. A sole operator may place an advertisement in a print publication classified by the Office of Film and Literature Classification. The advertisement must not offend the provisions of the *Prostitution Act 1999*.

8. Any advertisement intended for a publication classified by the Office of Film and Literature Classification must be individually submitted to the PLA for consideration using the application form for brothel advertising approval (see attachment B).

Yellow Pages advertisements

- 9. In order to obtain approval, the advertisement may be a maximum of a 20 unit advertisement (215mm by 253 mm) and may include the following information:
 - The name of the person or business, provided that the name does not describe the services offered
 - Approved words and phrases (see Attachment A)
 - The address, telephone and contact details and other relevant information.
- 10. An advertisement may include approved line drawings, pencil renderings and/or photographs. Approval will only be given to line drawings, pencil renderings and photographs that are not likely to offend the general public.

Internet advertising

- 11. Any proposed advertisement on the Internet must be submitted to the PLA for individual consideration using the application form (see attachment B). The sole operator must submit the proposed advertising material both in electronic and hard copy format.
- 12. The PLA will not allow advertising on the Internet which contains advertising for any other business or product or which permits access to or links the advertisement with any other site on the Internet unless the same has been approved by the PLA.
- 13. Any changes to the website, whether material or not, must be approved by the PLA. Proposed changes must be submitted in both electronic and hard copy format.

Business cards

14. Business cards are of a standard width (9cms x 5.5cms). Any "hand out" type of advertisement in the form of a business card shall comply with paragraphs 3, 4 and 6 hereof and shall not exceed 9 centimetres by 5.5centimetres.
