TERMS & CONDITIONS OF USE

3.1 Registration to be completed

4.1 Enrolment

Scarlet Alliance will issue a confirmation email to the email address provided on the enrolment form. Confirmation of receipt of enrolment form is not a guarantee of acceptance to the online training. If deemed eliqible you will be supplied with login details.
